# The Law Revision (Penalties in Criminal Matters) Miscellaneous Amendments Bill

Proposed provisions for amendment

## Object of the Bill

- The object of this Bill is to amend -
  - the Penal Code Act, Chapter 120 of the Laws of Uganda;
  - the Anti Terrorism Act, 2002 (Act No. 14 of 2002);
  - the Uganda Peoples Defence Forces Act, 2005 (Act No. 7 of 2005); and
  - the Trial on Indictments Act, Cap 23.
- The Bill seeks to amend these laws in order:
  - to remove the mandatory death penalty prescribed by these laws;
  - to restrict the death penalty to certain specified serious crimes by converting other provisions prescribing a death penalty in these enactments into imprisonment for life
  - to remove the restriction on mitigation in the case of convictions that carry a death penalty.
