### Background

Parliamentarians for Global Action (PGA) is an NGO network of over 1,302 individual legislators from 143 countries working on human rights issues. In 2014, PGA launched its *Global Parliamentary Campaign to End Child, Early and Forced Marriage (CEFM)* to raise awareness about this harmful practice, mobilize its network of Parliamentarians to discuss and address its root causes and consequences in the lives of girls and women in their countries and regionally, and empower them to strengthen their national legal and policy frameworks to accelerate its eradication.

### Purpose of Seminar

- Follow-up on the commitments adopted by Parliamentarians in Ghana (2014) and Tanzania (2015) on CEFM and assess their preliminary results;
- Build political support to foster an enabling legal and policy environment that protects women's and girls' rights;
- Facilitate engagement between members of Parliament (MPs) and all relevant stakeholders working in this field, especially between MPs and civil society;
- Promote cross-learning among African Parliamentarians to consolidate a network of peers working together to end CEFM in the region;
- Discuss strategies on how to implement and monitor at the national level *PGA's Global Parliamentary Declaration to End Child, Early and Forced Marriage* in line with Sustainable Development Goal's target 5.3 calling to an end of this practice;
- In Ghana, build capacity and political support among MPs on the current development of a National Strategic Framework to End Child Marriage led by the Ministry of Gender, Children and Social Protection as well as in harmonizing the Children's Act with the Child and Family Welfare Policy (2015).
