Mission of the PGA Secretary General to Kiev, Ukraine



On 2-5 October 2017, the Secretary General of PGA, Dr. David Donat Cattin, conducted a field mission to Kiev, meet with the Chair of the PGA Ukraine National group Hon. Nemyria and the Secretary Hon. Zalishchuk, and advance the process towards full implementation and ratification of the Rome Statute of the ICC by Ukraine. The meeting touched on protecting human rights and freedoms in Ukraine, the current state of the justice system, and the prospect of ratification by Ukraine of the Rome Statute.
