While 2020 has been characterized by the 'natural disaster' caused by the novel Coronavirus pandemic, the perpetration of genocide, crimes against humanity, war crimes or the crime of aggression continues to generate 'human-made' humanitarian disasters with armed conflicts and violent repressions that are causing immense suffering for victims and affected communities. Impunity for such crimes of concern to the International Community as a whole must be put to an end. The Rome Statute of the International Criminal Court (ICC) of 1998, as amended, creates the only permanent system of international jurisdiction aimed at fighting impunity for atrocity-crimes and preventing their repetition.

The CAP-ICC is the largest project of PGA's Campaign for the Rome Statute of the ICC. Since 2002, this bi-annual meeting represents a unique opportunity for legislators from all regions of the world to discuss and develop strategies to advance the universality and effectiveness of the Rome Statute system. This year, the CAP-ICC will be held virtually because of the restrictions stemming from the current global health crisis. Despite the circumstances, Parliamentarians continue to have a key role in serving as an essential bridge between the Executive and the people they represent, demanding and overseeing prompt and effective action from their Governments and the International Community. Now more than ever, Parliamentarians need the support of their peers from around the world to share strategies and effective responses to strengthen democratic institutions and domestic and international responses to human rights violations under the Rule of Law.
