Empowering Action on the Escazú Agreement: A Parliamentarians & Civil Society Dialogue

Session overview and objectives

This session, jointly hosted by Parliamentarians for Global Action (PGA) and ParlAmericas, will bring together parliamentarians and civil society representatives from the Caribbean SIDS for a dialogue on the <u>Escazú Agreement</u> as a critical framework for effective and inclusive environmental governance that contributes to the region's sustainable growth. Focusing on access to information, participation, and justice for all human rights defenders in environmental matters, the Agreement lays out a pathway for environmental action from a human rights-based approach.

Parliamentarians' unique role ensures effective environmental governance is incorporated as a cross-cutting priority throughout their portfolios, and encourages them to engage in various public mechanisms to reflect inclusive environmental decision making. The session will explore:

- The role of parliamentarians in the effective implementation of the Escazú Agreement through the use of digital tools and other public engagement mechanisms;
- The role of parliamentarians in ensuring the recognition, protection, and promotion of the rights of access to information, participation, and justice for all human rights defenders in environmental matters through the Escazú Agreement as an innovative tool.
