





NGO Roundtable on the Fight against Impunity and victims' access to justice

Organised by Redress, African Rights, Parliamentarians for Global Action and the Coalition for the International Criminal Court (CICC)

The Coalition for the International Criminal Court (CICC), Parliamentarians for Global Action (PGA), African Rights and Redress, with the support of Johan van Hecke (Member of the European Parliament) and Denis Polisi (Vice- President of the Rwandan Parliament) will hold a side-event in the margins of the ACP¹-EU Joint Parliamentary Assembly (JPA), taking place in Kigali, Rwanda, from 17 to 22 November 2007.

The event will bring together parliamentarians from the ACP and European countries, experts in international criminal law, civil society, as well as representatives of EU institutions. Participants will seek to identify steps to take in the fight against impunity for serious international crimes and to ensure justice for victims of those crimes in the regions.

To that end, the effectiveness of existing international and national accountability mechanisms will be analysed, with a focus on victims' means to access justice.

Both the preamble² and art. 11.6^3 of the revised Cotonou agreement include a clear commitment of ACP and EU states to combat impunity and promote justice through the ICC. The roundtable

² "Reaffirming that the most serious crimes of concern to the international community must not go unpunished and that their effective prosecution must be ensured by taking measures at the national level and by enhancing global collaboration; Considering that the establishment and effective functioning of the International Criminal Court constitute an important development for peace and international justice."

³ "In promoting the strengthening of peace and international justice, the parties reaffirm their determination to: (a) Share experience on the adoption of legal adjustments required to allow for the ratification and implementation of the Rome Statute of the International Criminal Court and (b) Fight against international crime in accordance with international law, giving due regard to the Rome Statute. The parties shall seek to take steps towards ratifying and implementing the Rome Statute and related instruments."

CICC: An informal network of Non-Governmental Organisations (NGOs) and individuals working together to support the creation of an effective and just International Criminal Court (ICC

REDRESS: An international NGO that works to obtain justice for survivors of torture and related crimes and end impunity for governments and individuals who perpetrate it and ensure compliance with international standards.

African Rights: A Kigali based NGO working on accountability for serious international crimes, in particular the Rwandan genocide. Parliamentarians for Global Action (PGA): a network of 1300 legislators from 117 elected Parliaments who works together to contribute to the creation of a *Rules-Based International Order* for a more equitable, safe and democratic world.
