Parliamentarians for Global Action (PGA), a non-profit, non-partisan international network of over 1300 legislators in more than 100 elected parliaments around the globe, aims to promote peace, democracy, the rule of law, human rights, sustainable development and population issues by informing, convening, and mobilizing parliamentarians to realize these goals.

How We Work:

PGA's program of work is under the political direction of an Executive Committee of 15 members. This structure allows PGA to effectively advocate policies at the national, regional, and international levels. By regulation the Executive Committee must retain a 40:60 gender ratio for either gender. The Executive Board elected by the International Council represents all the regions of the world. PGA also works closely with the UN system through the advisory body of PGA's UN Committee comprising senior UN ambassadors, high-level UN officials, and some leading NGO representatives. PGA also has had an extremely effective track record with intergovernmental agencies such as the UNFPA, UNDP. UNEP. UNICEF. UNIFEM, UNESCO. the World Bank, Asian Development Bank, and International IDEA. PGA's programs on Peace and Democracy, Sustainable Development, Health and Population, and International Law and Human Rights work in close cooperation with NGOs and leading research institutions in these fields.
