1. 20 – 22 September 2010

High-level Plenary Meeting of the sixty-fifth session of the UN General Assembly

Attainment of the MDGS has been an integral part of PGA's work for a number of years. Gender equality advancement is one of the MDGS and so the outcome of this High Level Plenary Meeting will be of particular interest to MPs involved in PGA's Health and Population Programme, especially in the lead up to our Annual Forum in Istanbul, Turkey next month which many of you are attending. PGA will be monitoring the proceedings and a number of our MPs will be in New York during this High Level Dialogue. If you are going to be here, but have yet to notify us, please do so as soon as possible so that we can brief you further and involve you in any PGA or PGA-related activities during this time. PGA will be closely monitoring proceedings, in particular the outcome document in the context of Health/HIV/AIDS and Gender Equality Advancement.

2. 23 - 30 September 2010

Sixty-fifth session of the UN General Assembly - General Debate

This is the annual UN segment where Heads of State/Prime Ministers from all of the 192 UN Member States make their own respective presentations within the UN GA on how they view the world in the year that has gone and the main challenges that are to follow. Once these presentations are completed at the end of the month, the different UN Committees will meet through December 2010 to discuss and agree on GA resolutions in their respective spheres of responsibility.

At PGA we will be tracking all deliberations, in particular closely monitoring the work of the First Committee (Disarmament) in particular this year, to the extent that any resolution adopted makes reference to the area of SALW and/or the proposed Arms Trade Treaty.
