

Parliamentary Campaign for the Effectiveness and Universality of the Rome Statute of the International Criminal Court (ICC) System (*PGA ICC Campaign*)

PGA is a network of over 1300 members from 131 Parliaments around the globe who, in their individual capacity and using their prerogatives as law-makers, undertake initiatives to support the ICC and the rule of law. As of 1 April 2011, the different initiatives and activities of these MPs have contributed directly to 68 of the 114 ratifications/accessions to the Rome Statute of the ICC to date, including the recent ones of St. Lucia, Seychelles, Bangladesh, Czech Republic, Chile, Suriname and the Cook Islands.

The trans-regional and national mobilization of parliamentarians, supported by the PGA Secretariat, ensures accurate analyses on the different issues stalling the ICC process in different countries and the multi-partisan involvement of stakeholders to overcome these obstacles and challenges. The tailored initiatives and activities of the Campaign are structured in such a way so as to ensure 'cross-fertilization' between international and country-specific activities.

PGA also participates actively in the ongoing international campaign to increase support for the Court, in particular in enforcing outstanding ICC arrest warrants.

Since the II half of 2010, PGA engages in parliamentary mobilisation in States Parties to ensure the prompt ratification, as well as the domestic implementation, of the Kampala Review conference amendments to the Rome Statute incorporating a definition and jurisdictional regime for the crime of aggression, as well as the use of certain prohibited weapons in the list of war crimes in non-international conflicts. PGA has identified the following **target countries** in which legislators can contribute in a concrete way to ensuring the goals of universality and effectiveness of the Rome Statute system to end impunity for the most serious crimes of concern to humanity as a whole:

The Kenyan Int. Crimes Act, sponsored and supported by the multi-party PGA Group, has been adopted by Parliament on 11 Dec. 2008 and entered into force on 1 Jan. 2009. Additional legislation is needed for Kenya to exercise jurisdiction over "post-electoral violence" cases (Dec. 2007-Jan. 2008).

² <u>Madagascar</u> joined the Rome Statute on March 14, 2008, after that it had amended its Constitution to finalise the ratification process, regarding which Parliament had approved the ICC Ratification Bill at the end of 2006.

³ In Oct. 2010, PGA submitted amendments and integrations to the ICC Bill to the <u>Mauritius</u> Government, which has been tabled before Parliament at the end of 2010. PGA Members had been instrumental to ratification in 2002.

⁴ The Parliament of the <u>Seychelles</u> adopted the Rome Statute Ratification Bill with a unanimous, bipartisan vote on 13 July 2010, allowing Seychelles to become the 112 State Party in August 2010. PGA worked with majority and opposition in the Seychelles in 2002, 2009 and the first half of 2010.

⁵ <u>Uganda</u> has been successfully targeted by PGA as the ICC Act (2006) was unanimously adopted by Parliament in third reading on 10 March 2010 thanks to the leadership of PGA MPs led by Mr. S. Tashobya, MP (Chair, Legal and Parliamentary Affairs Committee). Ugandan PGA MPs are engaged in promoting political, administrative and budgetary measures to give effect to the ICC Act and new reparations-programmes for the benefit of victims.

⁶ In <u>Chile</u>, PGA Members have promoted the adoption of Legislation to implement the principle of complementarity and a constitutional amendment to allow Chile's membership in the ICC system, which had been identified by the parliamentary opposition as legislative preconditions to ratification. As these steps have been finalised in April and May 2009, ratification occurred in June 2009, as announced by PGA Members in the parliamentary debates.

⁷ <u>Suriname</u> joined the ICC on 15 July 2008, as a result of the mobilisation of a multi-party group of MPs led by PGA member Dr. R. Wijdenbosch.

⁸ In <u>The Cook Islands</u>, Cabinet approved the ICC accession bill on 25 June 2008 and it became a State Party on 18 July 2008. The ICC process was led by Mr. Wilkie Rasmussen, MP, Minister for Foreign Affairs and Co-Chair of the *ACP-EU Joint Parliamentary Assembly*, who joined PGA after the ICC debate initiated by PGA members at the ACP-EU JAP Session in Ljubljana in March 2008.

⁹ The <u>Czech Republic</u> deposited its instrument of ratification on July 21, 2009, but the Upper House of Parliament had approved the Ratification Bill in July 2008 and the Lower House did the same on October 29, 2008, with a qualified majority vote of 140 MPs in favour and only 6 MPs against.
