### 1. 10<sup>th</sup> ASP of the International Criminal Court – United Nations – 13-21 December 2011

Although the ICC is not part of the UN system, the Assembly of States Parties of the ICC regularly holds its meetings at the United Nations to facilitate participation by as many ICC States Parties as possible.

During the course of the 10th ASP of the ICC, a new Prosecutor was elected, to take up her position in June 2012 (the current Deputy Prosecutor Fatou Bensouda of The Gambia) and Six New Judges were also elected to the Court – from the Philippines, Trinidad and Tobago, the Dominican Republic, Czech Republic, Nigeria and the United Kingdom. This was also the first ASP meetings of the ICC in which the new President of the ASP, Ambassador Intelmann of Estonia presided. Also during the course of the ASP ICC, and as the only parliamentary representative, PGA Member Hon. Kulasegaran MP (Malaysia) made a presentation to the ASP on behalf of PGA and the Non-Governmental Community.
